Tuition Payment Policy and Plans:

Plan A: Full Year

Full payment for the entire academic year is due on the **first day of class** in September.

Plan B: 3 Installments If your child takes more than one class per week, payments are due on the **first class of the week** indicated below.

First payment due: first week of class in September

Second payment due: week of December 1st

Remaining balance due: week of March 2nd

Tuition must be paid in full on the due date according to the chosen payment plan. An additional 15% will be added on all late payments; \$20.00 charge for all returned checks. Tuition may not be prorated or refunded.
